Throughout the 2024–2025 school year, our School Advisory Council (SAC) continued to support and monitor the implementation of the P–2 (3) literacy initiatives, focusing on reading and writing development. We provided regular updates on student progress and celebrated successes and next steps each term.

Professional development remained a priority, with a focus on literacy (Reading P–3 / Writing P–5) and math computational fluency (P–5). This year, we reported on additional

professional learning sessions for P–5 teachers on writing instruction. I shared that this year we also benefited from coaching support in math for our P-1 French Immersion teachers, enhancing instructional practices with computational fluency instruction in grades primary and one.

Our School Success Plan (SSP) goals and strategies were shared and discussed during all SAC meetings. We shared information on our short-cycle goal setting and planning and provided regular updates on progress and adjustments as needed.

Finally, the new Code of Conduct and Guide for Responding to unacceptable behaviour was shared with our SAC members. We reviewed our professional learning around the Safe Schools strategy. We shared and received feedback on our school Vision and Values statement and School Wide Matrix of Expectations. This work will be on going in the 2025 and 2026 school year.

A key focus for our School Advisory Council this year was to support our music program, math computational fluency, tier 2 vocabulary instruction and writing in literacy.

Expenditures supporting the school improvement plan (e.g., providing resources to support math and literacy instruction).

SAC spending was directly aligned with improving math instruction and supporting literacy short cycle goals. Specifically, funds were used to purchase math manipulatives and other instructional resources. In literacy, monies supported the development of story bins created by our P-2 teachers to target tier 2 vocabulary instruction. Additionally, SAC funds were allocated to purchasing nonfiction books that integrate content areas such as Science, Social Studies, and Health. These resources help build tier 2 and tier 3 vocabulary in context, supporting both literacy development and cross-curricular learning. The SAC also purchased books to add to our French Immersion classroom libraries. Finally, our SAC supported our music program adding technology upgrades to choir microphones and instruments for the music classroom.
